(a) and (b) Amount beneficially owned:

- (i) TRV III directly owns 1,839,160 shares of Common Stock (the "**III Shares**"), which represents approximately 3.8% of the outstanding shares of Common Stock.
- (ii) TRV GP III is the general partner of TRV III and may be deemed to beneficially own the III Shares.
- (iii) TRV GP III LLC is the general partner of TRV GP III and may be deemed to beneficially own the III Shares.
- (iv) TRV IV directly owns 2,132,867 shares of Common Stock (the "**IV Shares**"), which represents approximately 4.4% of the outstanding shares of Common Stock.
- (v) TRV GP IV is the general partner of TRV IV and may be deemed to beneficially own the IV Shares.
- (vi) TRV GP IV LLC is the general partner of TRV GP IV and may be deemed to beneficially own the IV Shares.
- (vii) As a managing member of TRV GP III LLC, Tepper may be deemed to beneficially own the III Shares. Additionally, Tepper directly owns 229,504 shares of Common Stock.
